I like the idea of a 'Type 3' Block Management Area with stricter criteria for hunters. I think this could help with a number of problems that Montana hunters are facing. First, this could open up large amounts of inaccessible land for hunters that might help to push elk off of private lands, which has been a big problem. Second, this would help dilute the number of hunters on public land, relieving some of the overcrowding that has been a problem addressed in other recommendations. Third, this program would provide hunters with higher quality land to hunt than they might otherwise be on, leading to higher harvest rates and higher hunter satisfaction.

I do, however have some serious concerns about parts of this recommendation.

The inclusion of options for hunters paying for hunting access is a death sentence for this program. The whole point of the BMA program is to provide hunters with access to private land without a cost. With the option for landowners to charge for access, this will become nothing more than a state-run guiding business. Those who would pay for hunting access will already do so through private means to hunt exclusive pieces of land. The incentive for landowners to open up their property in this should be the same as it is for Type 1 and Type 2 BMAs - monetary rewards from the state and the management of wildlife on their land - this time with the knowledge that only hunters of the highest quality are being allowed on.

I think FWP and the recommenders of this program need to be careful about what they consider a "quality hunter". Many hunters who exhibit high harvest rates and are efficient in their hunting are not ethical hunters - they do not consider Fair Chase in their endeavors. On the flipside, many hunters who these criteria may not consider highly successful are the most ethical hunters out there because they respect the land and the animals.

Relying on an app for this seems like a bad idea. Phones die, cell signal is spotty at best in much of Montana, and it is not accessible by the whole hunting public. Much of the ideas revolving around an app could just as easily be accomplished via communication between the hunters and landowners.

While I think the idea of a Type 3 BMA is a phenomenal idea, FWP needs to be extremely careful that they are not just setting up a new easy-money scheme for large landowners. As written, this recommendation could be easily perverted by landowners and result in wasted money on the part of hunters and the state.

I apologize because I know my comment is in the wrong recommendation because I don't know where best it would fit. I have a few small ideas that combined may be helpful. 1) Landowner tags very similar to New Mexico's program. The landowner receives tags for them to sell to hunters at their discretion. Often the landowner opts to sell the tags to an outfitter who turns around and sells the whole hunt. However, when the landowner elects to receive "ranch only" tags, ONLY their deeded land is huntable with their tag. Conversely, a ranch that is comprised of land locked BLM, FS, DNR, and deeded land, that landowner may choose to elect to have unit wide tags given to them to sell, except when they elect unit wide tags be given to them (to compensate for elk and hunter damages), they agree to all lawful elk hunting elk access. This plan would keep outfitters in check as far as how many hunts they can sell- which I think are making elk hunting a rich man's game; but doesn't by any means put them out of business. It gives the landowner financial compensation for the damages elk and hunters cause and could lead to access for hunters.

The \$4million question is how can anyone learn to gain access to the millions of acres of land locked public land elk have refuge, and hunters have no access - which they absolutely should. Could FWP lease rights of way during the hunting season using a system similar to block management?

Access Plus Program: First we must realize that logically an elk herd's current size represents the True "natural objective." All other measures of "objective" are defective because they have ignored 1 or more variables which establish an objective and Therefore are just wishful thinking. Elk herds located on property without unlimited hunter access are NOT part of an "over objective" formula.

Objective formula: habitat + hunter access + land owner tolerance + bull objective = True Natural Objective.

Property owners should collect the contact information of every hunter who harvests animals and invite them back each year. Private property owners need "killers," not hunters if they want a herd size reduced.

I hunt private property and I have harvested up to 6 deer in one day for a rancher who wanted deer removed, I have harvested 2-elk, 2deer, and 2-antelope in one year; all on private property, ONLY because the property owners wanted them removed. I am a killer not a hunter. We do not eat wild meat, we pay for the processing and donate ALL meat to a food cupboard.

It was obvious to Private Property owners, when they purchased property, that there is wildlife. It was known that the wildlife belongs to the citizens of Montana AND there is no constitutional requirement that the wildlife MUST be managed to maximize private property income; there was full disclosure, there are no secrets and therefore no surprises.

The statistics show that the more bulls desired requires a larger herd of cows. 100 Cow Elk only create 5-30 calves per year. If 60 bulls are harvested then it requires 185 replacement calves (40% will die in the first year) or 615 cow elk. In this perfect world we are assuming that hunters can harvest 100% of the 5-7 year old bulls. Since hunter success is only about 20% we need 300 bulls to stalk. This requires 1000 calves for replacement or 3000 cows for production. If 100% of cow elk produced a calf then we could manage for smaller herd size. However, as long as we want 30 bulls per 100 cow ratios we have to accept 3000 herd sizes. The only way to reduce herd size is to reduce the number of bulls. All of the data reveals that those herds who lay on or below the objective curve only have 5-15 bulls per 100 cows AND also contain the most public access.

THE Access Plus Program would turn Montana into a European style of hunting. How much government does Montana need to micro manage the Public's Wildlife? There is a discussion regarding humane harvest. I realize that a wounded animal, running across a field, tugs at our heart strings; BUT, it will die, it will provide food for other wildlife, and it is removed from the troublesome herd, therefore it helps to meet the "objective." Even I have lost an animal.

Throughout this entire scoping process, we have not compared the "objective" setting system for mule deer to the "objective" setting system for elk. It appears that mule deer are creating very little anguish. Therefore, we study the possibility of adopting the mule deer system for elk.

Conclusion: private property owners need to collect contact information of successful hunters and invite them back.

Dear FWP and the Elk Management Citizen Advisory Group -

Thank you for the opportunity to comment on your 'Access Plus Program' proposal.

The Montana Chapter of Backcountry Hunters & Anglers supports the general idea of Access Plus and recognizes the overlap between parallel conversations happening around the idea of a similar, Type 3 Block Management Program, which is mentioned in this description. In theory, expanding access and creating new opportunities in premier areas or private lands seems like a reasonable trade off in exchange for higher levels of required hunter/landowner education and standards of ethics and proficiency.

If this expands access and opportunity, it could be a valuable tool to manage current inaccessible elk on private lands. These property owners could relax a bit knowing the caliber of hunters that are allowed to participate. This sounds like a viable strategy to us.

That said, there are few guarantees that this program would be successful or that it wouldn't result in existing block management participants simply changing from Type I or II to III rather than attracting new landowners to the program.

The time commitment required for a course of this magnitude – especially with an in-person marksmanship component - would likely deter the masses from completing the training, leaving a smaller but qualified pool of potential sportsmen and women to participate in the early phases of the Access Plus Program. As noted by FWP, we too see this being very similar to the existing Master Hunter program.

Because of this, however, we are concerned that this will be tough to expand to reach the number of participants needed to make a real impact here, especially considering how unreasonable it may be to expect non-residents (a significant part of our current problem in regard to hunter behavior) to travel long distances for this required training.

We encourage the department to consider revamping existing, digital hunter/landowner relations education curriculum to use as the required course/training to qualify for not just this program, but any private lands enrolled in any public access programs administered by FWP (so existing Type I and II BMAs, hunt rosters, 454s, upland game bird enchantment areas, etc). That way we could improve hunter behavior and landowner relations across the board while allowing existing private programs like the Montana Master Hunter Program to continue to operate in this exclusive, small-scale way.

And yes, we agree that for this program proposal and many others, that mandatory harvest reporting would be helpful. We encourage FWP to implement this change.

Thank you again for the opportunity to comment on your 'Access Plus Program' proposal, and we appreciate your careful consideration.

The access plus program seems a little exclusive as the only people that can participate are those that have the time to attend these classes outside of a busy work schedule. I would agree with this program if it is made equitable and accessible. A potential consequence to think about is this new program could pull landowners away from type 1 and type 2 BMAs, therefore actually resulting in less access. Type 1 BMAs arguably result in some of the most access and it would be a shame to lose them to a program that results in less access. The one strike policy seems a little harsh if the hunter isn't even responsible for the accused behavior. I disagree with landowners charging a fee because this is a slippery slope. Landowners may shut down their property to these access programs to just keep charging access fees. This could also result in transferable landowner tags down the road. While I disagree with a fee, if there is one, there needs to be a cap. It is unfair to put money into a program that is only accessible by those that have the money to be able to pay higher fees for access. Instructors for hunter education are already difficult to obtain and I am concerned this new program would also have an instructor shortage.
