Finally, we would also strongly encourage the department to take this idea one step further and implement mandatory harvest reporting via their app and/or online. This is the only way to ensure the accuracy of the harvest data FWP receives, as voluntary data shared by the public would be skewed to only show data collected by those who choose to share it with FWP. There would be absolutely no way to know what the margin of error is with this kind of data. With mandatory harvest reporting, the margin of error would be significantly smaller, and the public could be put at ease knowing that FWP's decisions are based on the best science available.

RMEF recommends FWP revise data collection methods for elk counts, hunter participation, and harvest estimates to connect hunter effort, elk harvest, and population objectives at relevant spatial scales. Current elk counting methods are not sufficient to provide the level of accuracy needed to align population objectives and inform management decisions. Sightability (or other statistical) models are a more appropriate method to estimate population abundance and trends by Elk Management Unit (or another spatial scale). RMEF also recommends implementation of a mandatory harvest reporting system, which would allow for a substantial increase in data quality and quantity, along with improved data sharing and transparency.
