2 MEETING MINUTES

- A. Jamie Mongoven (FWP) reviewed the pre bid meeting agenda included in *Exhibit 2*.
 - a. The following items were added/clarified during presentation of the agenda:
 - i. Bid Opening Date/Time is February 5, 2025 at 3:00 PM Local Time. Bids to be delivered to FWP Design and Construction Office at 1522 9th Ave., Helena, MT 59601.
 - 1. Note that mail deliveries to this location can be unpredictable. Recommend hand delivery if possible.
 - ii. Engineer's Opinion of Probable Construction Cost = \$340,000
 - iii. The project duration is 90 calendar days from the date of the notice to proceed.
 - 1. The Notice to Proceed date can be requested by the selected contractor based on contractor's schedule with the following criteria:
 - a. The project shall be complete by October 31, 2025 at the latest. Therefore, the latest notice to proceed date shall be August 2, 2025.
 - b. For consideration, the site is typically less busy by July.
 - iv. This project only includes a base bid. There are no bid alternates.
 - v. Typically 1 pay request per month.

- vi. 50% of mobilization is eligible for payment with the first pay request.
- vii. These meeting minutes will be posted on the FWP website.
- viii. Addenda will be posted on the FWP website
 - 1. It is the Contractor's responsibility to visit the FWP website to identify addenda and acknowledge addenda with the bid submittal.
 - 2. Addendums will not be sent directly to each contractor.
- ix. FWP has obtained the following permits for the project:
 - 1. MDT Approach Permit
 - 2. County Septic Permit
 - 3. SPA 124 Permit
 - 4. Floodplain Permit
 - 5. Section 404 Permit
 - 6. 318 Authorization
 - 7. 401 Certification

The Contractor is responsible for obtaining a Stormwater Pollution Prevention Plan if deemed necessary by the Contractor.

- B. Brad Koon (Triple Tree Engineering) provided an overview of the project.
 - a. The area south of Rock Creek includes reclamation, re-vegetation, and barbed wire fencing.
 - b. The area north of Rock Creek includes an asphalt pavement approach up to the right-of-way.
 - c. New barbed wire fencing included along the MDT right of way with a cattle guard at the approach.
 - d. Smooth wire fencing and gates required for internal areas.
 - e. Gravel access roads in accordance with typical section.

- f. Gravel parking areas in accordance with typical section.
 - i. Concrete parking barriers.
- g. Culverts at approach and under boat ramp turnaround
- h. Latrine
 - i. Contractor is responsible for purchase and installation.
- i. Concrete boat ramp.
 - i. As noted in the plans, pre-cast push in concrete is required below the waterline with cast-in-place above the water line.
- j. Barrier rocks
 - i. There were questions regarding the large boulder in the parking area.
 - 1. The large boulder in the parking area has been removed and will no longer be installed as part of the project. Addendum 1 addresses removal of the boulder from the project.
- k. Stormwater Pond
 - i. Grade as shown on the plans.
- l. Signage
 - i. Contractor to purchase and install signage included in the bidding documents.

- 7. Insurance: Cover type of limits and coverage (All Projects)
 - a. \$1,000,000/ occurrence; \$2,000,000 aggregate
 - b. Must cover vehicles used by company
 - c. State of Montana must be identified as an additional insured
- 8. Buy Safe Montana Provisions Instructions to Bidders & General Conditions
 - a. Successful bidder will be required to provide their incident rate, experience modification rate (EMR) and loss ratio with first pay request (Instructions to Bidders, Article 14).
 - b. To promote safe work environments the successful bidder must maintain an EMR of less than 1.0; or loss ratio of less than 100%. A loss ratio of more than 100% must obtain a safety consultation with the Montana Department of Labor & Industry; Employment Relations Division; Safety Bureau before the owner grants Substantial Completion of the work (D&C Form 14).
 - c. Contractors shall require subcontractors with an EMR or loss ratio greater than above to schedule and obtain a comprehensive safety consultation as described.
 - d. Successful bidder will need to obtain the EMR of Loss Ratio for all subcontractor's before work is started.
