



## **2025 Special Recreation Permit Application for Commercial Use: Madison River**

It is a violation of FWP/BLM rules to conduct commercial use on the Madison River without a Special Recreation Permit.

Permit Fees		
The permit fee for commercial use on the Madison River is 3% of your annual unadjusted gross revenue. Annual unadjusted gross revenue is the total amount of unadjusted income you earn from commercial use of the Madison River from January 1, 2025 through December 31, 2025.		
A \$110 minimum fee payment is required when applying for the Madison River Special Recreation Permit. The remainder of the permit fee must be paid in full by January 10, 2026.		
SRP Boat Tags		
Each watercraft operating under your permit must display a set of valid Madison River Special Recreation Permit (SRP) boat tags (2 tags per set) when conducting commercial use on Madison Rivers. You are responsible for proper placement and replacement of you and your guides' boat tags.		
SRP boat tags may not be permanently attached to a boat. If you or your guides have SRP boat tags permanently attached to a boat, remove them. SRP boat tags must be <b>completely visible</b> , <b>detachable</b> , and <b>displayed on both sides</b> of the boat in a <b>conspicuous location</b> .
