It is a violation of FWP/BLM rules to conduct commercial use on the Madison River without a Special Recreation Permit.

Permit Fees

The permit fee for commercial use on the Madison River is 3% of your annual unadjusted gross revenue. Annual unadjusted gross revenue is the total amount of unadjusted income you earn from commercial use on the Madison River at BLM sites only from January 1, 2025 through December 31, 2025.

A \$110 minimum fee payment is required when applying for the Madison River Special Recreation Permit. The remainder of the permit fee must be paid in full upon receipt of the 2025 Madison Report Form.

SRP Vehicle Tags

Each vehicle operating under your permit must display a valid Madison River Special Recreation Permit (SRP) vehicle tag when conducting commercial use on BLM Recreation Areas along the Madison River. You are responsible for proper placement and replacement of you and your employee's vehicle tags.

SRP vehicle tags should be place in a conspicuous location on the dash.
