# Come Home to Hunt

A bill was passed promoting Montana's family hunting heritage by creating nonresident combination hunting licenses for use by adult (18 years or older) nonresident family members who wish to return to Montana to hunt with a family member. Under this law, up to 500 Nonresident Big Game Combination, 500 Nonresident Elk Combinations and 500 Nonresident Deer Combination licenses can be issued. All money received from the sale of these licenses must be used by the department to acquire public hunting access to inaccessible public land.

## INSTRUCTIONS FOR COME HOME TO HUNT

### Part A: Mandatory to be Completed by the Applicant

- \* All information in Part A must be filled in completely by the applicant.
- \* Applicant must be 18 years of age or older to apply.
- \* Applications must be on the current year's department approved form.
- \* The nonresident applicant must have completed a Montana hunter safety course **AND** have previously purchased a Montana resident hunting license.

#### Previously held Come Home To Hunt licenses do NOT count as a resident license.

- \* The nonresident applicant must be sponsored by a family member within the second degree of kinship (see definition below) and must be a resident as defined in MCA 87-2-102, who is 18 years old or older and possesses a 2024 Montana resident hunting license.

### Part B: Mandatory to be Completed by the Adult Sponsor

- \* All information in Part A must be filled in and completed by the application.
- \* Applicant must be 18 years of age or older to apply.
- \* Applications must be on the current year's department approved form.
- \* The nonresident applicant must have completed a Montana hunter safety course AND have previously purchased a Montana resident hunting license. Previously held Come Home to Hunt licenses do NOT count as a resident license.
- \* The nonresident applicant must be sponsored by a family member within the second degree of kinship (see definition below) and must be a resident as defined in MCA 87-2-102, who is 18 years old or older and possesses a 2024 Montana resident hunting license.
- \* The second degree of kinship includes a mother, father, brother, sister, son, daughter, spouse, grandparent, grandchild, brother-in-law, sister-in-law, son-in-law, daughter-in-law, father-in-law, mother-in law, stepfather, stepmother, stepbrother, stepsister, stepson, and stepdaughter.

### Part C: List the Family Members Who Will Hunt with the Nonresident Applicant.

The nonresident applicant who receives a license must be accompanied in the field by a family member(s) who are residents as defined in MCA 87-2-102, who are 18 years old or older, possesses a current 2024 Montana resident hunting license, and who are related to the nonresident within the second degree of kinship as described above.
