**Instruction To Resident Landowner Sponsor Applicants:**

Montana state law (87-2-511 MCA) provides that deer combination licenses may be offered to nonresident deer hunters indicating their intent to hunt with a Montana resident sponsor on land owned by that sponsor. Resident is defined in 87-2-102, MCA. A sponsor is defined as a resident individual, or a resident individual of a domestic corporation or partnership created pursuant to Montana statutes. A landowner sponsor who fails to submit required records for the prior year will not be eligible to sponsor nonresident applicants for the current year. A landowner sponsor may submit a maximum of 15 certificates of sponsorship per year. Upon approval of this application, a landowner sponsor certificate will be sent to you for your signature and distribution to the applicants.

I certify that:

1. I am a Montana resident owning 640 or more contiguous acres.
2. I will direct the nonresident applicant's hunting and advise the applicant of game and trespass laws of Montana.
3. I will submit to FWP, complete records of who hunted with me, where they hunted and what game was taken. Reports must be postmarked by the December 31 2024.
4. I will accept no monetary consideration for enabling the nonresident applicant to obtain a license.
5. I will immediately notify the FWP office if there are any changes in my land ownership (including acreage), mailing address, or residency.
6. I understand that if I do not provide all required information, I will not be eligible for this program.

- ❖ Complete the attached legal description(s) or geocode(s) of all land to enroll in this program.
- ❖ Sponsored Hunters may not hunt land not enrolled through this certification process.
- ❖ Include a copy of your current, valid Montana Driver's License.
- ❖ Landownership listed in the name of a Corporation, Sole Proprietorship, Limited Liability Company, Partnerships, Trusts or Association must provide documentation of have the legal authority to sign on behalf of that business (i.e. Articles of Incorporation, Partnership Agreement, Certificate of Trust, ect.)
