**Background:** Recently completed fisheries monitoring surveys on Holter Reservoir showed declines in yellow perch abundance and continued low abundance of walleye. Fisheries management decisions for Holter Reservoir are guided by the Upper Missouri River Reservoir Fisheries Management Plan 2010-2019. The current plan sunsets at the end of this year and a draft update of the plan is currently under public review. Yellow perch abundance has been declining steadily since achieving record high levels in 2013, and low abundance recorded this year warrants management action as defined in the 2010-2019 plan. Walleye abundance in Holter has been below management goals the past 3 years, but with the decline detected this year the department has determined that additional management action is warranted. The department is proposing to lower the yellow perch limit on Holter from 50 fish daily, no possession limit to 25 fish daily and in possession. To maximize effectiveness, the department would prefer to implement this regulation January 1. For walleye, the department is proposing to lower the walleye limit from 10 fish daily, only 1 over 25 inches to 5 fish daily, only 1 over 25 inches. Possession is twice the daily bag limit. This change is not as time sensitive as perch, but approval by December would ensure a regulation change is included in the printing of the 2020 Fishing Regulations booklet.

**Public Involvement Process & Results:** Low perch and walleye abundance and need for management action was very recently discovered, so minimal public process on this specific proposal has occurred. The 2010-2019 Management Plan was approved by the commission and underwent extensive public review. The current draft plan has been crafted through extensive public input and additional public review is currently underway. The proposed management action meets criteria defined both in the 2010-2019 plan and the draft plan currently under public review. The department plans to conduct a brief public comment period on this specific proposal before final action is taken at the December commission meeting.

**Alternatives and Analysis:** The department believes it is important to implement a more conservative perch fishing regulation prior to the winter ice fishing season. If the commission approves this proposal and if adopted at the December meeting, the department could implement the regulation by January 1 and the change would appear in the 2020 Fishing Regulations booklet. The change would need to be communicated via typical public outreach and signage prior to distribution of the new regulations booklet in March. Adoption of a walleye regulation is not as critical since most walleye harvest occurs during the open water season; however, it would be helpful and improve compliance if a new regulation is included in the printed regulations booklet.

**Proposed Motion:** I move the commission approve the proposed changes to yellow perch and walleye bag limits and collect public comment on the proposal.
