While I can appreciate the effort of stocking pheasants on state owned land, habitat improvement/preservation should be either equal or higher on the priority list. One small example is state lands bordering my ranch in central Montana. I own OBrien Inc in T14N R15E, with two state parcels that border us (480 acres total). The state owns roughly 1.3 miles of easily accessible river bottom (Ross Fork Creek). My dad worked with the state on game bird habitat improvement roughly 30 years ago, but since then I haven't seen or heard anything. Our game bird populations in the area have large swings up and down, which I believe is due mainly to the lack of habitat and winter cover. Even with little to no cover, we continue to have good numbers of hungarians, sharptail, and some pheasants. This area would be an ideal place for not only a habitat improvement project, but also pheasant release to improve the numbers. Both state parcels have easy access, are relatively flat and easy to walk for hunters, are very near communities (Moore, Hobson, Lewistown) and have plentiful food sources for birds. We just lack the necessary cover to help stabilize our bird populations. The area is a favorite among local hunters already. I commend the FWP for trying something new and I hope that this bird release will help improve the hunting experience for hunters of all ages. I would be happy to help with releases or work on habitat improvements again, both on state lands or my private ranch. If we build the habitat, bird numbers will likely improve and lead to a more sustainable future for hunting in Montana.

I am against FWP's Pheasant release proposal for 3 reasons:

- 1) Prison Labor is unethical. I wouldn't buy consumer products made by people who are paid pennies on the dollar for their work, and I don't think it's acceptable for the state or our hunters to benefit from that either. Let's end indentured servitude, especially for recreational purposes;
- 2) Pen-raised and planted birds should not be a substitute for better habitat management. I can't tell you how many State Sections I've walked onto hoping for a good hunt, only to leave disgusted because it's been hammered, whether grazed to stubble, hayed, or cultivated and left scabby and weed covered. A single lessee should not have the right to degrade a piece of land that hundreds of others use and benefit from, even if those benefits are non-monetary. Take that \$1M and invest it in shelter belts, feed plots and teach our kids that habitat is key— then they'll learn why it's called HUNTING and not KILLING, and that it's supposed to be a challenge (and see #3, below);
- 3) Finally, until MT reforms our model for funding, particularly bird hunting and fishing, where individuals pay once for what is increasingly dozens or even scores of days of pressure on the resources. With people living longer, retiring earlier, and spending more time hunting, our revenues are flat or decreasing, while the pressure on the resources is increasing. Change the model so that more hunters-- particularly out of state hunters that pay a fraction of what they should to bird hunt and fish in one of the best states in the whole union to do so-- help expand the protected, publicly accessible, hunting estate. Under the current system, we're just subsidizing the degradation of pheasant populations that are already under heavy pressure.

Please know that I'm a grateful user of Montana's State Lands. My comments reflect my deep appreciation for, and intention to keep, using them for the rest of my life, and for my children's grandchildren to do the same. Thanks for hearing my comments.

The Montana Chapter of Backcountry Hunters & Anglers (Montana BHA) represents roughly 3,000 dues-paying sportsmen and women in Montana who value robust fair-chase opportunities and public access. Above all else, we value quality habitat that fosters healthy populations of wildlife.

It comes as no surprise that our Chapter vehemently opposes FWP's proposed Motion to approve the release of pheasants on state-owned lands for calendar years 2022-2026.

What was a terrible idea just got worse: avian flu is here and spreading.

FWP's April 18th press release cautioned hunters of the dangers, stating the "Highly pathogenic avian influenza (HPAI) virus was detected in a snow goose from Canyon Ferry and a Canada goose from near Belgrade last week. HPAI was detected earlier this month in domestic poultry in Judith Basin and Cascade counties... HPAI viruses are extremely infectious and fatal to poultry and some species of wild birds." Now the first case of a transmission to humans (at a poultry plant at a prison) has just been reported. More than 25 states have confirmed the disease and had to destroy millions of birds already.

Poultry farms are on high alert and biologists and epidemiologists are both concerned of the potential devastating impacts of the disease. Nowhere will HPAI spread more quickly than at a pen-raised stocking facility. Regardless of what precautions FWP promises, once there's an outbreak, at best, the entire flock will need to be wiped out, making this program an even bigger waste of license dollars; at worst, diseased birds will be released and infect wild populations of game birds, or humans.

This new variable alone should be enough to shut down this proposal, immediately.

But alas, if risking our entire wild bird populations and putting the health of Montanans in jeopardy is not enough, we have other longstanding concerns.

While HB 637 authorized the department to spend up to \$1M each fiscal year for a pheasant-stocking program, this legislation does not mandate that FWP actually do it. Repeatedly, hunters have asked that the department not comply, and instead, listen to the science and the concerns of Montanans; this is a waste of money, the wrong way to recruit new hunters or expand sustainable populations of pheasants, and poses significant threats to the health of our wild birds. The decision notice by the department to proceed with the project flies in the face of the strong opposition received by concerned sportspeople and conservationists. What is it going to take for FWP to listen to the people including their own field biologists?

We encourage the Commission to adopt the listed (and purposefully oversimplified, perhaps even misleading) alternative and "opt to not approve the release of pheasants for youth recruitment and retention." To move forward with this stocking facility at this time would not only be extremely unpopular and avoidable, it would be incredibly irresponsible.

I oppose the annual release of pen-raised ring-necked pheasants in an attempt to engage the youth in sport hunting and urge the Commission to stop this effort – it's expensive and the potential for disease transmission is a concern.

HB 637 provided funding for this is a waste of precious tax dollars. I don't have the exact amount of money spent on this effort in 2021, but based on information in the Environmental Assessment and Decision Notice, I'm estimating it cost over \$40,000 (2,094 birds were released at an estimated cost of \$20/bird = \$41,880). With 78 youth participating last year, this program cost at least \$536.92 per participant.

FWP recently halted their wild sharptailed grouse transplants and Wyoming Game and Fish recently euthanized 1,200 of their breeding pheasants to prevent the potential spread of avian influenza. This is a poor time to be increasing efforts to develop facilities to raise and release of up to 50,000 birds.

If you decide not to stop this project, I urge you to consider authorizing the continuation of this project only at the 2021 level, by purchasing birds, and not expending significant funds to develop facilities at the Montana State Prison.

Dear Montana FWP,

I appreciate all that you do to ensure the outdoor and hunting heritage of Montana. I am an aspiring wildlife professional and look up to you all as examples of the profession.

The reason I am commenting on your plan to release pheasants in region 3 is because of my interest in hunting. Being born and raised in Montana has made hunting a huge part of my life and I love to see efforts to expand opportunities. I do not think that pheasants are the correct way to expand on opportunities, however.

First, pen raised pheasants are significantly less likely to survive in the wild compared to wild birds (Diefenbach, Riegner, & Hardisky, 2000). This is well known by many so I will not bother by going into much detail and will provide studies for you to look over.

Second, parasitizing nests of native game birds is something pheasants do quite often (Geaumont, Sedivec, & Schauer, 2010). This is a particular issue west of the continental divide because of the large decrease in sage and sharp-tail grouse numbers.

Third is my personal opinion. There is nowhere near the sense of accomplishment killing a bird that was raised in captivity. I pursue animals because they are wild. Shooting a bird that has seen a few BBs fly passed him and has lived his whole life to survive is much more of a reward. If you decide to stock birds how would a person distinguish wild from captive. This would persuade me to hunt a different location.

I also find much more joy in hunting animals native to Montana (not that I do not like to kill a pheasant now and again). I think that this funding would be more beneficial going to habitat projects to further help our native game birds and not be a possible pressure of them. I hope for a day when I can drive a few hours from my home and hunt sage grouse, prairie chickens, and sharp-tail grouse. You all are our part of the path to make that happen.

If you could please explain why the reasons that I listed are not realistic issues, please write back to me.

I'm opposed to the pen reared release program for several reasons. In the late 1970's I worked at the Warm Springs "bird farm" where I was involved with raising pheasants for fall release. These were birds raised from incubators on site and gradually transferred to chicken wire covered runs. Most of these had vegetation in the form of yellow rapeseed for cover and possibly some feed although they were fed birdseed primarily. Crowning in the early stages led to high mortality and following release survival was not only very low but because they were raised in pens that were only 5-6' high, they learned to run rather than fly from danger. If your idea of sportsmanship is ground sluicing and if you don't mind your hunting dog "retrieving " an unshot bird that refused to flush then this is the program for you. Finally,Im guessing the cost/ bird has not declined in the past 46 years. Folks,

The EA and decision to release up to 50,000 pen-raised pheasants does not reveal the cost of this action. The Legislature simply directed the department to spend UP TO \$1 million a year on the releases, but it did not require the department to spend that much. FWP needs to state precisely how many birds it will release per year in the next five years, where they will be released and how much it will cost per year. I recommend the department use an adaptive management approach that only incrementally increases spending on this program, and that any annual increases should be based on annual monitoring that meets the objectives of introducing and retaining new hunters. FWP should not have a goal of blowing a million dollars each year on this program. These funds are better spent on other programs that benefit wild fish and wildlife and the habitat that supports them.

All previous releases of pen-raised pheasants in Montana have produced little to no documented public benefit. Certainly FWP has never really demonstrated empirically any significant, let alone measurable, benefit to Montana bird hunters, among others. And so, FWP should scale down this proposal. Releasing anything near 50,000 birds a year will provide, at best, a negligible and short-term benefit because of the documented high natural mortality rate that occurs within a short period after birds are released. Most of these birds will perish from weather, predation, starvation or disease. The Legislature stated that the primary objective of this program is to increase recruitment and retention of new, young hunters. In the EA FWP says it will monitor this objective, but it doesn't say how this will occur. FWP also never addresses how exposing new hunters to the exercise of shooting newly released pen-raised pheasants contributes to education of these new hunters to fair-chase hunting, the standard of most hunting of game species in Montana.

Basically, this is an ill-conceived and unnecessarily costly program. FWP should be very precise in how it monitors the program to demonstrate to the public, and lawmakers, genuine success and, of course, failure.

Dear Montana Fish, Wildlife and Parks Commissioners,

The following letter represents Pheasants Forever's formal position regarding Montana Fish, Wildlife, and Parks' (MTFWP) proposed programmatic pheasant release program. As the nation's largest upland habitat conservation organization whose mission is grounded in science, we believe (1) the pheasant stocking effort is a detriment to the incredible wild bird hunting opportunities in the state of Montana and (2) the program lacks meaningful steps to track recruitment, retention, and reactivation (R3) of Big Sky hunters.

Pheasant Stocking is Futile

Stocking of pen-raised pheasants is not an efficient means to increase wild bird populations, as shown by numerous studies over the past 40 years (see attachment). Additionally, genetic dilution of wild bird stocks and the potential of disease transmission is a real threat. Developing and enhancing habitat, on the other hand, has proven to help increase ring-necked numbers along with other iconic Montana wildlife species.

R3 Efforts Deserve Evaluation

Under the context of the North American Model of Wildlife Conservation, of which hunters have led, Pheasants Forever has made R3 activities a priority. We acknowledge that MTFWP's proposed pheasant release program may contribute to hunter recruitment and retention efforts. However, we believe any R3 benefits of released birds are dependent upon MTFWP strategically coordinating and promoting new hunter opportunities, rather than intending releases to augment wild bird populations. To that end, we strongly encourage the commission to only approve the pheasant release program intended to promote youth hunter recruitment activities once a monitoring mechanism has been identified.

Recommended Next Steps

- Metrics and Evaluation: As suggested above, R3 program monitoring should be identified to assess return-on-investment for taxpayers.
- Funding Considerations: Pheasants Forever recommends one year of R3 program funding, followed by a reassessment of the program's effectiveness in achieving the state's R3 goals.
- Habitat Management: Instead of propagating pen-raised birds at Deer Lodge State Prison, task inmates with habitat improvement projects through the state nursery, or meaningful work on public lands that can contribute to a brighter future.

In closing, Pheasants Forever vehemently opposes the use of funds for the purpose of stocking pheasants for establishing or supplementing existing wild pheasant populations. We also see shortcomings in the proposed release program for R3 purposes and strongly encourage further development of the MTFWP's plan for this intent. Instead, Pheasants Forever would welcome the opportunity to work with MTFWP and the legislature to develop a solution directing these funds toward habitat efforts that would provide more benefits to upland birds, iconic wildlife, and a wider array of Montanans.

Pheasants:

I am an avid and active upland bird hunter, and I am opposed to the pheasant release plans on State owned lands. These releases are problematic for scientific, social, and ethical reasons. I'll elaborate on each below.

First, the science demonstrates that it won't help pheasant numbers. As Musil and Connelly (2009) demonstrate, survival rates for released pheasants are abysmal. Money invested in management of existing habitat, or acquisition of new habitat would yield a far better return than pen-raised pheasants. What's more, those investments would expand, rather than concentrate, the pheasant hunting opportunities for all hunters in Montana.

Second, the "fish in a barrel" nature of released pheasant hunts does not increase youth participation or interest in hunting. I've watched far too many kids have to kick pen raised birds to get them to flush, or even worse, just shoot them on the ground, which is dangerous for them, their dogs, and other hunters. As you all know, the experience of hunting is VASTLY more than killing. Let's invest in helping our kids see THOSE benefits. The sunrise, the frost on the grass, the pheasant tracks after a dusting of snow, and the thrill of watching a dog work, all of which are wonderful with our without a dead bird in hand.

Finally, the ethics. I love hunting and outdoor recreation, but my recreational opportunities will NEVER justify slave labor. Specifically, I'm referring to prison populations paid pennies on the dollar to raise birds for recreational purposes. Prison labor is unethical; full stop. We shouldn't be using it at all, much less to subsidize "fun."

Please oppose the motion, take the \$1M allocated for pheasant rearing and release and invest it in something that will provide real benefits for hunters and the resource: HABITAT.
