Currently, there is no reason, biologically or socially, for a shortened season in this hunting district. As explained by the Department at a prior Commission meeting when considering wolf seasons, the Northern Yellowstone elk herd is robust and there are no conservation issues for this herd. Therefore, keeping a shortened season in this hunting district would serve no useful purpose to counteract any conservation issue. Instead, it will only serve to unnecessarily limit hunting opportunity and public access to public lands for the purposes of elk hunting. While I do not personally hunt in this district, I know many individuals who do and they are frustrated that their opportunities are severely limited while others who hunt in other districts are not. The shortened season was a flawed and ill-advised measure that does not serve any useful purpose and simply limits hunting opportunity, which can have ramifications in increased crowding in other hunting districts.
