

2022 wolf quotas , 2022 harvest, and proposed 2023 quotas

NOTE: “Trapping Districts” with quotas replaced “Regions” for harvest regulation in 2022. However, “Regions” with quotas are proposed again for the 2023 wolf season. As proposed, wolf hunting and trapping will be closed after quotas are met. The proposed area for each Region is equal to the corresponding Trapping District from 2022.

2021 wolf season thresholds

NOTE: “Regions” replaced “Wolf Management Units” (WMUs) for the purpose of harvest regulation in 2021. When harvest within a region met that region’s commission-approved threshold, the commission was required to review regional harvest. Only the Region 3 threshold was met in 2021. The subsequent commission review stopped wolf harvest in Region 3.
