Re: Proposed Commissioner Amendments from Commissioner Cebull

To Whom It May Concern:

I submit the following comments on behalf of Hellgate Hunters & Anglers, a Western Montanabased organization that represents over 500 sportsmen and women across the state. We are grateful for the opportunity to comment on Commissioner Cebull's proposed amendments.

HHA provides the following comments on Commissioner Cebull's Proposed Amendment to the proposed 2024 and 2025 black bear regulations:

1. Set a statewide spring hunting season closure for Black Bear to June 15.

HHA generally does not have an issue with this amendment on a statewide level. However, HHA does have some concerns with relation to potential impacts on grizzly recovery zones, along with historic elk calving habitat. The potential for hunter related conflicts with grizzlies is very high in units in the grizzly recovery zone. This risk is exponentially increased in areas where hound hunting or chasing is allowed. Further, allowing bear hunting activity later into the season could potentially have negative impacts on calving elk. As such, HHA would like to see the Fish and Wildlife Commission take a cautious approach and consider retaining the current season closure date of May 31 in grizzly recovery zones and historic elk calving habitat. Further, HHA generally supports each item in the department response to this proposal regarding quotas, and not changing any units that already extend to June 15.

2. Expand to statewide the Region 1 pilot that allowed hunters to submit extracted teeth instead of having to present a head and carcass. Also require that each hunter submit 2 molars instead of 1.

HHA generally agrees with and supports the department response to this proposal. If the department would prefer a second year of data to determine the adequacy of the pilot program, the commission should follow the department's wishes. HHA also agrees that if this amendment were adopted, physical inspections should remain mandatory in Regions 5, 6, and 7. Finally, the

48-hour harvest report requirement should remain in effect in any regions where hunters are no longer required to present their harvested bear.

Regarding Commissioner Cebull's remaining proposed amendments, along with the amendments proposed by the other commissioners, HHA would like to make a general comment on this process as whole. The season setting process now allows the commissioners to have a second opportunity to provide input that the public does not have adequate time to vet. The public should have the same opportunity to comment that the commissioners do. The timeline involved in responding to commissioner proposed amendments such as this does not provide the public sufficient time to adequately analyze and understand the proposals. This undercuts the public's ability to participate and has the potential to put the general public on unequal footing with third party interests who may be influencing the commissioners to make changes after the season setting process is finalized.

Thank you again for the opportunity to comment on these proposed amendments.

To propose a change to the tag allocations for the fall of 2024 when the HD hasn't even been surveyed to assess population dynamics is reckless.

The bull to cow ratio is below the 2005 Elk Management Plan. I know this because it was discussed ad-nauseum last year when a similar motion was proposed. Your concern is that more cow elk should be harvested to make that ratio more balanced, but your solution is to increase either-sex tags? There are already 2 tag options available for cow elk harvest in the region and something tells me that folks with an either-sex tag aren't going to pass up a bull for the cow next to him.

MOGA SUPPORTS

Rationale

- On April 4, 2023, Region 7 announced they were reducing the Commission approved rifle quota for HD 700-20 from 250 to 200 (-50) and reducing the archery quota for the HD 700-21 from 800 to 660 (-140). Together these actions removed a total of 190 either-sex permits.
- The notion that HD 700 is managed as a "trophy district" has yet to be determined and has never been formally
 designated a trophy area. The imposition of the reduced permits in 2023 was a product of Regionally imposed
 preferences and not a product of formal public and Commission process.
- Results from the 2023 Montana Elk Hunter survey data clearly show there is little appetite for this kind of
 management. Almost 70% of respondents indicated a desire to hunt bull elk every year vs giving up opportunity
 to hunt a mature bull.
- The removal of 168 resident hunters and 19 nonresidents for a total of 187 hunters not only takes away sustainable public hunting opportunities, but has also cost rural communities, dependent on hunter-oriented tourism, an estimated \$220,000 in tourism dollars this year alone from local businesses in the 700 Hunting District.
- 2) Amendment to set a statewide spring black bear hunting season closure for June 15 and expand Region 1 pilot project, which allows hunters to submit extracted teeth instead of having to present a head and carcass, to the entire state. This would also require that each hunter submit two molars instead of one. Click here to see amendment. [Inks.gd]

MOGA SUPPORTS

Rationale

- A standard spring season event and closing date of June 15 will simplify regulations, provide accommodation for variable spring weather events, and afford sustainable hunting opportunities.
- Since black bear harvests are managed based on BMU/HD quotas a standardized closing date of June 15 would
 only remain if the quota was unfilled. Conversely the closure of BMU/HDs on June 1, when quotas are yet to be
 filled, is an unnecessary loss of otherwise sustainable hunting opportunity.
- There are many examples but several that most poignantly illustrate the issue: HD 393, HD 690, and HD 680, all have a June 1st closure for black bear.
 - o HD 393 is next to Bridger Bowl Ski Area. There are a lot of bears in that area, but access is usually a nightmare in May due to late winter and heavy snowpack. To the east is US Forest Service and it is very popular with public land hunters during the big game season. However, this same country sees little black bear hunting in the spring due to the inaccessibility imposed by a June 1 closing. As a result, black bear quotas are not filled and hunting opportunities are lost and black bear density remains high.
 - Region 5 is a mountainous area with a normally deep snowpack that prevents access for bear hunters, forcing all the activity on the lower lands. Significantly more opportunity, in both time and area, could be had with a June 15 closure.
- 3) Amendment to set the black bear season in bear management unit 520 to May 1 to June 15. Click here to see amendment. [Inks.gd]

MOGA SUPPORTS

Rationale

- BMU 520 lies along the northern and eastern face of the Beartooth Mountains. BMU 520 has a female harvest quota for the Spring of 12 sows which is typically filled very early in the season.
- By adjus ng the start date of the season from April 15 to May 1, this will allow the season to stay open
 incrementally longer and, hopefully, allow hunters to access more back country male bears that are unreachable
 due to snow in the early season.
- In addion, since sows are the key to maintaining a healthy popularon, we recommend that the Department implement bear ID training for hunters to help them be able to idenority sows to prevent the female harvest from closing the season so early

Commissioners,

I would like to express my support for Commissioner Cebull's Amendment to the Black Bear Regulations to extend the hunting season to June 15th Statewide. As a resident of Northwest Montana, the May 31st closure date in many of our black bear units in the northwest severely limits accessibility due to deep snow conditions. Simplifying the regulations and providing better access to areas that experience deep snow is a much-welcomed amendment.

I would also like to express my support for Chair Robinson's Amendment to eliminate the Deer B license for Either Sex Mule Deer LPT 699-20 in HD 600 & 670 and LPT 699-21 in HD 640 & 670. Deer densities in these districts have already been significantly reduced since this regulation change has been proposed. Adding additional take on mule deer with LPT 699-20 and 699-21 is too aggressive of a proposal given the current population declines that are being experienced with mule deer. If increased take could eliminate CWD from the landscape I would be in support of this regulation change, but increased take has only slowed the spread of CWD and has never eliminated it. The Departments focus should be on long-term solutions for CWD, not band-aid fixes. Thank you Chair Robinson for your amendment.

I appreciate the Commission's ongoing commitment to our state's wildlife.

Below are my public comments on Commissioner Cebull's Amendment.

In response to the first bullet point in the amendment, I strongly **oppose** the proposed increase in both the 700-20 and 700-21 licenses. As shown by the most recent survey, we are below the districts objective of 30 bulls:100 cows. If we are not going to follow guidelines on managing wildlife, then what purpose do they serve in the first place.

As to the second bullet point, I would hardly say that elk numbers in HD 700 are increasing. Between 2010 and 2020 numbers have stayed fairly steady between 1100 and 1500 total elk counted. This statement also doesn't take into account the proposed elk objective for HD 700 in the new Elk Management Plan that proposes an objective of 1600-2400 elk. We are effectively below objective going into the 2024 Hunting Season. The last thing we should be doing is increasing either-sex elk permits by 25% if we are effectively under objective.

For the last bullet point, I don't think it I wise to use economic factors as a basis for decision making when the topic at hand is a publicly owned resource. If we are going to begin to go down the economic path, I suggest we take a look at our overall tools of hunter distribution. Publicly accessible lands have become so overcrowded that, while we might be at a peak for economic activity at the moment, we are very close to having the floor fall out underneath us due to people giving up hunting all together because of the overcrowding.

Lastly, I oppose the amendment because it circumvents the public process of public meetings regarding these proposed changes. Having a public comment period during hunting season and the holidays is hard enough but adding last second amendments that dramatically changes the district I've been applying for over the last decade feels disingenuous.

I urge you to oppose the amendment to increase 700-20 and 700-21 licenses.

I move the Fish and Wildlife Commission adopt the following amendment to the proposed 2024 and 2025 Black Bear Regulations: 1. BMU 520: Set spring season to May 1 – June 15."

My public comment is as follows:

I have hunted Spring Black Bear in Unit 520 exclusively for the previous 3 seasons. Two years ago, I was able to kill a good boar on April 29th in the backcountry although "green-up" has yet to take effect and bear sign/movement was sparse. Last season, my hunting partner and I were significantly hindered from accessing/hunting our desired areas due to deep snow on the north slopes during the first week of May. I am in full support of the proposed amendment stated above by Commissioner Cebull. I believe this would disperse hunting pressure across the unit because more country would be accessible both by hiking trails and access roads during the latter half of May. Specifically, this would improve vehicle access along Iron Mountain Road and the southern extents of Derby Gulch Road, both accessing Gallatin National Forest in Unit 520. Also, the Meyer's Creek/Dead Indian area would be much more accessible under the new season dates.
