Today the U.S. Fish and Wildlife Service (Service) will open a public scoping period on a proposal to create a Missouri Headwaters Conservation Area in southwest Montana. Upon completion of the scoping period, the Service will consider next steps, which may include the development of a Land Protection Plan.

If created, the proposed Conservation Area would authorize the Service to work with willing landowners to purchase up to 250,000 acres of conservation easements within a proposed 5.7-million-acre boundary. No fee title acquisition would be authorized. Conservation easements in this area would help conserve important wildlife habitat and migration corridors for species such as grizzly bear, pronghorn, elk, mule deer, and bighorn sheep while also protecting open space and keeping working lands working.

The scoping period will run from September 20 – October 26, and the Service will hold three open-house meetings in southwest Montana during that time. Please see the copy of the Service's news release below for additional details.
