Flathead Wildlife, Inc. supports the proposals to amend bull trout fishing regulations in Hungry Horse Reservoir, the South Fork Flathead River including the mouths of Gordon and Little Salmon Creeks, and the area around mouth of Big Salmon Creek into Big Salmon Lake. Fish Wildlife and Parks data shows a decrease in bull trout redd counts. At the same time, surveys based on bull trout catch cards show an increase in angling pressure.

Bull trout in Montana are listed as a Threatened species under ESA and fall under management of the US Fish and Wildlife Service. Bull trout in the South Fork Flathead drainage are one of the healthiest populations in Montana so recreational angling has been allowed under a special permit from USFWS including a catch card system. There may be several factors influencing bull trout abundance in the South Fork drainage but the decline in bull trout redds is negatively correlated with an increase in angling pressure. Angling pressure is the easiest factor for FWP to control and a conservative approach is warranted to maintain the health of the fishery and the USFWS special use permit. Despite their large size and robust appearance, bull trout are sensitive to handling. They take lures deep and fight hard so they may be more susceptible to catch and release mortality. There are similar regulations throughout the Flathead drainage such as tributary mouth closures and angling closures to protect bull trout from excessive handling. Jim Vashro, FWI President
