Deer/Elk Hunting District 260 Migratory Birds Upland Game Birds

GENERAL INFORMATION

The "island" parcel of this 186-acre park is open to shotgun hunting (waterfowl & upland game bird) and archery hunting (deer & elk) for a portion of the 2020 hunting season. Hunting access is provided by Montana State Parks. Council Grove State Park provides hunters with access to adjacent federal lands.

HOW TO GET THERE

From Missoula, travel West on Mullan Road about 7 miles off Reserve Street. Look for park signs, turn left (West) off Mullan road, continue approximately ½ mile to parking area.

HUNTER REGISTRATION

Each hunter should <u>register daily at the park sign-in box before beginning to hunt</u> at Council Grove State Park or adjacent federal lands. Registration details are posted on site at the sign-in box. Each hunter upon registration shall display the daily registration coupon on the dashboard of their vehicle while hunting on Council Grove State Park.

REGULATIONS

- 1. Be considerate and aware of other recreationists and their pets. A bow case is recommended when traveling to and from a stand. Gut piles, feathers, & offal should not be left in highly visible areas.
- 2. All park regulations are in effect including: no fires, day-use only.
- 3. Failure to abide by these regulations can result in a violation of FWP Department or Commission orders or rules under MCA 87-6-201
- 4. Access is walk-in only. Game retrieval is by non-motorized means only.
- 5. A permit is required to hunt from a tree stand. It is only allowed with portable stands. Do not build permanent structures or platforms, cut limbs or otherwise damage trees. Tree stands may be set up no earlier than September 5th. All tree stands must be removed by February 1st. To obtain a permit please call (406) 542-5533.
- 6. Do not build waterfowl blinds. Portable blinds must be removed following the day of hunting.
- 7. **PARK SAFETY ZONE:** Do not shoot into the Safety Zone. The boundary of the safety zone along the Clark Fork River side channel begins & ends on the top of the riverbank and is marked by signs.
- 8. PACK-IN / PACK-OUT all spent shell casings, garbage, and hunting equipment/accessories.
